Duties of Assistant Director (S&R): The duties of the Assistant Directors (S&R) are inspections of Food Storage Depots, Procurement Centres, Railhead, Fair Price Shops and Rice Mills. He/She initiates spadework concerning complaints from concerned State Governments, rice millers and consumers, settles disputes between the State Governments and Food Corporation of India at the time of taking delivery of food grains stocks from FSDs and supervises the work of Technical Officers (S&R).

Place of posting: The place of posting will be S&R Division, Department of Food And Public Distribution but liable to be posted anywhere in India.
