DETAILED VACANCY CIRCULAR

Applications are invited from the eligible officers for filling up the post of **Assistant Professor (Sugar Engineering)**, a General Central Service, Group 'A' Gazetted, Non-Ministerial post in Level-11 of the Pay Matrix at National Sugar Institute, Kanpur – a subordinate office of the Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, by Deputation (including short-term contract). Details of the post, eligibility conditions etc. are given in the **Annexure-I**.


2. Applications of only such officers/ candidates will be considered as are routed through proper channel and are accompanied by:-

(i) Bio-data (as per the proforma given in **Annexure-II**) – each page of the Bio-Data and all supporting documents to be attested by an officer not below the rank of Under Secretary and certified by the Employer/ Cadre Controlling Authority.

(ii) Photocopies of APARs for the last five (5) years duly attested on each page by an officer not below the rank of Under Secretary.

3. Applications of suitable and eligible officers and who can be spared immediately in the event of selection may be sent directly to the Under Secretary (E.III), Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, (Room No. 484), KrishiBhawan, New Delhi – 110 001 within a period of **60 days** from the date of publication of this advertisement in the Employment News.

- (ii) Associateship of National Sugar Institute in Sugar Engineering awarded by National Sugar Institute or post-graduate diploma in Sugar Engineering from Vasantdada Sugar Institute, Pune after completing degree in Mechanical Engineering or Electrical Engineering from a recognized University or Institute; and
- (iii) Four years' practical or research or teaching or advisory experience of Mechanical Engineering or Electrical Engineering work in a responsible capacity, involving designing, erection and operation of up-to-date sugar manufacturing plant.

Desirable:-

- (i) Post-graduate degree in relevant branch of Engineering;
- (ii) One year experience of designing or operation or erection of modern sugar plant.

Note 1: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: The period of deputation (including short term contract) including period of deputation (including short term contract) in another *ex-cadre* post held immediately preceding this appointment in the same or some other

organisation or department of the Central Government shall ordinarily not exceed four years.

Note 3: The maximum age-limit for appointment by deputation shall be not exceeding 56 years as on the closing date of the receipt of applications.

Note 4: The qualifications are relaxable at the discretion of the Union Public Service Commission, for the reasons to be recorded in writing, in the case of candidates otherwise well qualified.

Note 5: The qualification(s) regarding experience are relaxable at the discretion of Union Public Service Commission, for the reasons to be recorded in writing, in the case of candidates belonging to the Scheduled Castes or the Scheduled Tribes, if at any stage of selection, the Union Public Service Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.
