**DETAILED VACANCY CIRCULAR**

Applications are invited from the eligible officers for filling up the post of **Assistant Professor (Physical Chemistry)**, a General Central Service, Group 'A' Gazetted, Non-Ministerial post in Level-11 of the Pay Matrix at National Sugar Institute, Kanpur – a subordinate office of the Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, by Composite Method: Promotion/ Deputation (including short-term contract). Details of the post, eligibility conditions etc. are given in the **Annexure-I**.
