#### **Export Release Order - 5**

**Subject:** Combined Export Release Order for sugar mills and exporter where sugar is being exported to Sri Lanka under one Billion US Dollars Credit Facility to the Government of Sri Lanka for import of various items including sugar from India.

Whereas, DGFT vide notification dated 24.05.2022 has placed Sugar (Raw sugar, Refined sugar & White sugar) bearing ITC (HS) Code 17011490 & 17019990 in "Restricted" category for exports. Further, DFPD vide letters of even number dated 24.05.2022 has issued letters to sugar mills as well as exporters along with the guidelines/procedure for applying/obtaining Export Release Order (ERO) for sugar mills and exporters.

- 2. Whereas, DFPD vide letters dated 05.06.2022 and 06.06.2022 combined export release orders to exporters and sugar mills have been issued.
- 3. Whereas, Government of India has extended one Billion US Dollars Credit Facility to the Government of Sri Lanka for import of various items including sugar from India and under the facility, various contracts f or export of sugar have been executed between exporters from India and importers from Sri Lanka.
- 4. Therefore, Directorate of Sugar and Vegetable Oils, Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, in exercise of powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 4 and 5 of the Sugar (Control) Order, 1966, hereby, grant permission to 13 exporters to export a total quantity of 60,614 LMT of sugar upto 31.10.2022 as mentioned in the **Annexure (exporter wise sugar mill wise)** subject to the following conditions:
  - a) Exporters shall submit proof to custom authorities that the sugar is being exported to Sri Lanka.
  - b) It should be ensured that the said quantity allowed for export shall not be further exported from Sri Lanka to any other country.

c) The exporter shall submit a report of implementation of Release Order after completion of such export to the Chief Director (Sugar).
