Minutes of the meeting of the Screening Committee under Sugar Development Fund (SDF) held on 06.06.2019

A meeting of the Screening Committee for consideration of the loan applications for Sugar Cane Development under Sugar Development Fund (SDF) was held under the Chairmanship of Joint Secretary (S&A) on 06.06.2019 at 11:00 A.M. in Room No, 41, Ground Floor, Krishi Bhawan, New Delhi. A list of participants is at Annexure-I.

At the outset, the Chairman welcomed all the Members of the Screening Committee. Thereafter, the agenda item was taken up for discussion with the permission of the chair. The observations/recommendations are as follows:

Agenda Item No 1: Proposal of M/s Shri Sai Priya Sugar Ltd., Vishal Nagar, Hipparagi- Albal Road, Tq: Jamkhandi. Dist.: Bagalkot, Karnataka for Cane development involving SDF assistance.

M/s Shri Sai Priya Sugar Ltd., Vishal Nagar, Hipparagi- Albal Road, Tq: Jamkhandi. Dist.: Bagalkot, Karnataka has submitted a proposal for SDF loan for Cane development involving SDF assistance of Rs.540.00 lakh. The application was recommended and forwarded by the State Government of Karnataka.

2. The Sugar Factory has submitted the loan proposal with a unit cost of ₹60,000.00 per hectare for Drip Irrigation system. The Committee observed that the least amount quoted for Drip Irrigation system as per the quotations submitted by the Sugar Factory was Rs. 42,449.94 per hectare. Accordingly, the eligible loan has been revised, considering the least quotation value as under:

- 3. As on 31.03.2018 based on ABS 2017-18, the DSCR of the sugar factory and company as whole is 1.05, FACR of the sugar factory and company as a whole is 1.408, and IRR for the project is 27.68%.
- 4. The Committee further observed that there is some discrepancy in the Recovery% and Pol% data of the last five years furnished by the Sugar Factory. The same is required to be clarified by the Sugar Factory. Also, expected benefit of Pol% Cane has not been furnished by the Sugar Factory. The same is required to be furnished by the Sugar Factory.
- 5. After due deliberations, the Screening committee, on the basis of the recommendation of State Government, technical and financial details, and eligible project cost, recommended SDF loan of \$173.07 lakh for 1^{st} year and \$272.16 lakh for 2^{nd} year for consideration of Standing Committee subject to furnishing the details as mentioned in para 4 above.

2. The Committee observed that the Sugar Factory has not furnished that baseline information for 'Expected benefits on completion of the project.' Also, the information is not correlating with the information mentioned in the appraisal report. Therefore, the Committee directed to re-examine the same and deferred the proposal to be considered in future Sub-Committee meeting.

Additional Agenda Item No 01: Proposal of M/s Sahakar Shiromani Vasantrao Kale Sahakari Sakhar Karkhana Ltd., At-Post-Bhalawani, Taluka Pandharpur, Maharashtra for Cane development involving SDF assistance.

2. The Committee observed that the Sugar Factory is incurring losses during the last five financial years. Also, the DSCR of the Sugar Factory and Company as a whole for the FY 2017-18 is 0.08. Therefore, the Committee deferred the proposal with directions to re-examine the financials of the Sugar Factory.
